Welcome to the 2010 boating season. This newsletter is a summary of important 2010 boating season information, event dates and membership information. Please inform your Harbour Master if there will be a delay or if you are not putting your dock in this year. Boat Club rules state if you do not put in a dock, your space will be given to the next boater on the list. Boats no larger than twenty-four foot are a reasonable limit acceptable for our river.



After a year of trying to get approvals the club finally managed to get a permit to remove the gravel bar in the channel in September. There was concern expressed that dredging then would only have to be done again in the Spring. Given the difficulty in getting a permit, the need to remove the gravel, and the possibility it would help with the Spring flood, the Directors decided to go ahead. Each year bring new challenges. A report will be made to the Spring AGM on May 23.
